

**MUNICIPAL ORDINANCE NO. 92A, Y. 2023**

**AN ORDINANCE AMENDING SECTION 6 OF MUNICIPAL ORDINANCE NO. 92, Y. 2023 – “ADOPTING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) OF THE MUNICIPALITY OF KALAYAAN, LAGUNA, PROVIDING POLICIES AND GUIDELINES FOR ITS IMPLEMENTATION AND FOR OTHER PURPOSES.” AND ADJUSTING THE NUMBERING AFTER SECTION 5 THEREIN WHICH WAS ERRONEOUSLY DUPLICATED.**

On motion of **Hon. SB Member Edison A. Flores**, duly seconded by **Hon. SB Member Beverly D. Reyes**, and **Hon. SB Member Laarni C. Lopez** and with unanimous consent of all members present there having a quorum;

**BE IT ENACTED** as it is **HEREBY ENACTED** by the *Sangguniang Bayan* of Kalayaan, Laguna, by virtue of the powers vested in it by law, in a session duly assembled, that:

**SECTION 1. - TITLE.**

This Ordinance shall be known and cited as “An Amendatory Ordinance to Municipal Ordinance No. 92, Y.2023 - Adopting the Local Public Transport Route Plan (LPTRP) of the Municipality of Kalayaan, Laguna, providing policies and guidelines for its implementation and for other purposes.”.

**SECTION 2. - RATIONALE.**

The Land Transportation Franchising & Regulatory Board (LTFRB) issued a Notice of Compliance to the Local Public Transport Route Plan (LPTRP) of the Municipality of Kalayaan, Laguna, directing the municipality to adopt the approved LTPRP through the passage of an ordinance which brought to the enactment of the Municipal Ordinance No. 92, Y.2023 - “Adopting the Local Public Transport Route Plan (LPTRP) of the Municipality of Kalayaan, Laguna, providing policies and guidelines for its implementation and for other purposes.”. The said ordinance was then endorsed to the LTFRB Central Office for the conduct of a transparent operator selection and issuance of franchise for

evaluation and approval. Upon review of the LTFRB Central Office it was recommended that a revision be made particular on Section 6 of the said ordinance wherein it was stated therein that the modification, amendment or any changes in the LPTRP can be updated "anytime" instead the recommendation is for modifications to be done only "once every three (3) years". This recommendation is also in accordance with the provision set forth in Section 5. THE MUNICIPALITY OF KALAYAAN ROUTE PLAN. as specified therein, "The approved LPTRP shall be updated at least *once every three (3) years* [emphasis added] from the date of issuance of the Notice of Compliance (NOC).

### SECTION 3. - AMENDMENTS.

- a. Section 6 of aforesaid ordinance which read:

Section 6. MODIFICATIONS AND ADDITIONAL ROUTES, UNITS AND AUTHORIZED MODES. The LPTRP can be modified, amended, expanded or updated such as shortening, extending or changing the routes *anytime* [emphasis added] during its effectivity to suit the transportation demands and development requirements of the Municipality of Kalayaan in accordance with applicable laws, rules and regulations.

IS HEREBY AMENDED by changing the word "ANYTIME" with:

**"ONCE EVERY THREE (3) YEARS"**

THUS, Section 6 will be amended and read as follows:

Section 6. MODIFICATIONS AND ADDITIONAL ROUTES, UNITS AND AUTHORIZED MODES. The LPTRP can be modified, amended, expanded or updated such as shortening, extending or changing the routes, *once every three (3) years* [emphasis added] during its effectivity to suit the transportation demands and development requirements of the Municipality of Kalayaan in accordance with applicable laws, rules and regulations.

- b. Corrections on section numbering shall be applied due to duplication of section number 5 in the aforesaid ordinance. THUS after Section 5. LEGAL FRAMEWORK AND COMPOSITION OF THE LPTRP TEAM. section numbering will be read as follows:

Section 6. THE MUNICIPALITY OF KALAYAAN ROUTE PLAN.

Section 7. MODIFICATIONS AND ADDITIONAL ROUTES, UNITS AND AUTHORIZED MODES.

Section 8. QUALIFIED OPERATORS AND TRANSPARENT COMPETITIVE SELECTION.

Section 9. COMPLIANCE WITH LOCAL REGULATIONS.

Section 10. SANCTIONS FOR INIMICAL ACTS.

Section 11. SEPARABILITY CLAUSE.

Section 12. REPEALING CLAUSE.

Section 13. EFFECTIVITY.

Section 14. SERVICE OF COPIES TO APPROPRIATE GOVERNMENT AGENCIES


SECTION 4. - This Ordinance shall take effect immediately upon its approval.
