RESOLUTION NO. 12 - 2024


A RESOLUTION DECLARING EVERY 23RD DAY OF MARCH EVERY YEAR AS "TRES BARRIOS FESTIVAL" OF KALAYAAN, LAGUNA, COINCIDING WITH ITS FOUNDING ANNIVERSARY CELEBRATION FURTHER DECLARING IT AS THE HIGHLIGHT PRESENTATION OF KALAYAAN SOCIO-CULTURAL ACTIVITIES.

WHEREAS, every year, the Foundation Day of Kalayaan, Laguna is commemorated every 23rd of March. It is a week-long celebration highlighting the town's people, culture, customs and traditions, a showcase of local talents and a smorgasboard of socio-cultural activities offering the best venue and platform to convey to as many people as possible its own share of cultural wealth and flaunting the very asset and pride of the town which are its people - the Kalayaeños;

WHEREAS, now on its 116th Founding Anniversary this year, to be celebrated from the 18th of March and to culminate on the 23rd of March, 2024, this annual event will be more festive and memorial if a festival name will be created for its distinct recognition like most festivals in different municipalities and cities of Laguna and other provinces;

WHEREAS, on January 31, 2024, the Office of the Sangguniang Bayan received an endorsement from the Office of the Mayor requesting to pass a resolution or an ordinance declaring every 23rd of March every year as "TRES BARRIOS FESTIVAL" of Kalayaan, Laguna. coinciding with its Founding Anniversary Celebration;

WHEREAS, the catchy and unique name is in honor of the three visitas: originally





called ABACAO, BABAYE and SAN PABLO (currently as SAN JUAN, LONGOS and SAN ANTONIO respectively). Kalayaan is the only municipality in the entire province of Laguna that has only three (3) barangays;

WHEREAS, the name TRES BARRIOS FESTIVAL of Kalayaan, Laguna has its generic theme which is "SARILING PRODUKTO, LAGING TANGKILIKIN", aside from highlighting the town's harvests, culture, history and tradition, it also imparts the spirit of patronizing and giving due importance to local products and produce rather than from external sources, giving a sense of loyalty and belongingness, motivating a deep connection with the community;

WHEREFORE, in view of the foregoing and on motion of Hon. SB Member Veelly Jhames L. Cabamalan, duly seconded by Hon. SB Member Beverly D. Reyes and Hon. SB Member Aldrin A. Agana, and with unanimous consent of all members present, there having a quorum it was:
